

Why gifts in wills matter

The College is a charity and gifts in wills provide a vital source of income. In recent years, bequests have helped fund bursaries and scholarships, teaching and research, student life and the very fabric of the College. The importance of our benefactors' generosity is illustrated below.

Our aim is to provide an education recognised internationally as being of the highest standard. We want make a Caius education as affordable and appealing as possible, and to prepare our students to play full and effective roles in society. This means providing financial help to those who need it and the very best resources and opportunities for all, whilst managing rising costs and limited income from tuition fees.

Student funding



Income from students (tuition fees, accommodation and catering charges)

Note: Students paid no rent when not in residence during the COVID-19 pandemic, which reduced income. Caius spends more than £2 on education for every £1 received in tuition fees. This equates to a shortfall of almost £5 million a year – or more than £5,000 per student.

Over the past ten years, the College has received £15 million in bequests from more than 100 donors. This represents 30% of all charitable income during this time. Bequests of all sizes make a significant difference to our students.

Student support


The costs of a university education are substantial. Loans for tuition fees and living expenses are available to many but entail sizeable debts. Moreover, these loans are failing to keep pace with the rising cost of living which the College must recognise in its accommodation and catering charges. Increasingly students must rely on often scarce additional sources of funding. Your bequest could help provide invaluable bursaries, scholarships and hardship grants to those in need.

Teaching and research

The supervision system of undergraduate teaching is invaluable. Providing more than 20,000 hours of supervisions every year is also expensive. The research carried out by our vibrant community of postgraduate students and Research Fellows is integral to the College's work, but also requires significant investment. Your gift could support teaching costs or provide research grants.

Widening participation

Our Access & Outreach team's work aims to encourage more applications from currently under-represented backgrounds. They also seek to raise pupils' aspirations and enable them to make better-



informed educational choices. Previous successes have been underpinned by donations and your support could help continue, and further expand, our work.

College life

The pursuit of academic excellence remains central to the College's mission, but the Caius experience goes far beyond supervisions and the library. Today there are 40 College sports clubs and societies. We must continue to support extracurricular activities and do more to ensure that all students can benefit from participation.

Buildings and facilities

The College is both a home and a place of learning. Many Caians retain fond memories of living here, perhaps in Old Courts, Harvey Court, Mortimer Road or the Stephen Hawking Building. It is important that we maintain our historic buildings and invest in new facilities that best serve the evolving needs of our community.

How to make a gift in your will

You should consider how you would like to benefit the College and the type of gift you wish to leave. **I** We appreciate that for many people, a will is a personal matter. You may choose to keep your intentions private. If, however, you would like to discuss your plans, in confidence, then we would be happy to hear from and help you. We always recommend consulting your solicitor before making or amending your will.

The most common ways of leaving a gift in your will are explained below.

A share of your estate (a 'residuary legacy'): A gift of all or part of the residue of your estate after all specific gifts and expenses have been met. Many people choose to leave a percentage of their estate to Caius.

A specific sum (a 'pecuniary legacy'): This is straightforward but the real value of your gift could decrease with inflation over time.

A gift of shares or property (a 'specific **legacy'):** Please speak to us if you are considering a gift of shares, property or personal possessions such as works of art or jewellery.

A 'reversionary legacy': This method enables your estate to support loved ones during their lifetimes, with the College receiving the benefit thereafter.

Tax-effective giving

UK Inheritance Tax

Gonville & Caius is a charity registered in **England and Wales** (number 1137536). **Bequests to charities** are exempt from **Inheritance Tax.** Your gift is deducted from the value of your estate, thereby reducing overall Inheritance Tax liability.

In addition, if you leave 10% or more of your estate to charities like Caius, vour Inheritance Tax rate is reduced from **40% to 36%.** For more information, please speak with your solicitor or financial advisor, or visit www.gov.uk/donating-tocharity

Residents of the **United States** may choose to make a bequest to the Caius Foundation, which is a tax-exempt organisation registered under section 501(c) (3) of the IRS Code. Please consult your legal advisor, who will need the Caius Foundation's business address: 1350 Avenue of the Americas, Floor 2, Suite 266, New York, NY 10019.

For residents of **Canada**, the University of Cambridge is registered as a qualified charity with the Canada Revenue Agency (number 825341233 RP0001). A gift in your will to Gonville & Caius is 100% taxdeductible. Tax on your estate is calculated once all charitable gifts have been met, thereby reducing overall tax liability.

Elsewhere, including several **European countries**, it may be possible for you to make a taxeffective bequest. Please contact us if you would like to discuss your options.




Recognising your generosity

The Edmund Gonville Society recognises Caians and friends who include Caius in their will. As of June 2022, the Society had more than 330 members. From 2022/23, the Society will gather for lunch annually in College, providing members with an opportunity to meet friends, students and Fellows. A deed of variation

A deed of variation allows you, as a beneficiary under a will, to transfer all or part of your inheritance to Caius. Such gifts to the College can receive favourable Inheritance Tax treatment. Please speak with a professional advisor if considering this means of supporting the College.
